# Minutes

The Eastern Kentucky Board of Directors (EKCEP BOD) held its quarterly meeting on December 14, 2023 at 10:30 a.m. The hybrid meeting was held at 412 Roy Campbell Drive Hazard, Ky or via Zoom (if requested).

## Welcome, Roll Call and Introduction of Guests

EKCEP BOD 's Vice Chair, Gilbert Holland called the meeting to order. The roll call resulted in 21 BOD members being in attendance.

### Minutes Approval

Gilbert Holland asked for an approval of the September 14, 2023 minutes. Connie Barnes made the motion to approve. Walter Nixon seconded the motion. All voted in favor, none opposed. The motion carried

## **New EKCEP Board Member Introduction**

Gilbert Holland introduced Greg Motley and Derek Jorge Campbell as new EKCEP BOD members.

### WIB Member Approval

Rebecca Miller, EKCEP Executive Director, told the attendees that Jeff Johnson will become a member of the EKWIB. He was nominated by Vic Adams to represent small business.

### **Executive Committee Appointment**

Gilbert Holland appointed Albey Brock as a member of the EKCEP Executive Committee. Gilbert Holland asked for a motion. Terry Adams made the motion to place Albey Brock on the EKCEP Executive Committee. Bishop Johnson seconded the motion. All voted in favor, none opposed. The motion carried.

All voted in favor, none opposed. The motion carried.

# **Employee Evaluation and Pay Adjustment Policy Change**

Gilbert Holland asked for a motion to approve the compensation and pay practices as discussed and as amended with the consistent wording of "increase" instead of "adjustment" and to keep the \$5,000 cap. Rodney Chrisman made the motion to approve. Connie Barnes seconded the motion. One nay and all others voted in favor. The motion carried.
