# Minutes

The Eastern Kentucky Workforce Innovation Board (EKWIB) held its quarterly meeting on December 11, 2024 at 2:00 p.m. Due to weather conditions the meeting was conducted via Zoom.

# Welcome & Call to Order

EKWIB's Chair, Keith Gabbard called the meeting to order. All board members were reminded to have their cameras on during roll call and voting. Chair Gabbard also asked board members to state their name as they made 1<sup>st</sup> or 2<sup>nd</sup> motions. The roll call resulted in 13 WIB members being in attendance.

# Approval of September 2024 EKWIB Minutes

Keith Gabbard asked for a motion to approve the September 11, 2024 EKWIB minutes. Bruce Carpenter made the motion to approve the minutes. Brent Sturgill seconded the motion. All voted in favor, none opposed. The motion carried.

## **HR Policy Update**

# Fund Development
